Year-End Trading Update

Cobra Biomanufacturing Plc (AIM: CBF), today updates the market on its performance for the financial year ended 30 September 2007.

Following the announcement on 28 June 2007, management effort to generate new business has resulted in future customer commitments at a record level of £6.3m, although there is insufficient revenue for delivery in the second half of the current financial year to prevent a shortfall against current market expectations.

Consequently unaudited revenue for the year is expected to be marginally less than market expectations at around £9.0m, which is expected to give rise to operating losses in the region of £1.7m. The cash at bank at the year end will be approximately £1.5m.
